ITEM 5 ITEMS FOR DISCUSSION

5.1 Community Park- Updated By Sarah Caporn

- Open to the public.
- Official opening, ribbon cutting on the 15th of September 2023 @ 3pm.
- CCTV has been approved and ready to be installed.
- Issues with the ablution blocks.
- Was a delay with power but is now working.
- Multiple kids jumping on trampoline.
- Injuries around the playground. Multiple accidents have occurred.
- Concerns about the steel metals around the park are too risky and dangerous.
- A suggestion about having some sort of rubber edging over the steel edging.
- Bikes should not be in the park (maybe some signage to let the public know).
- It's recommended that unsupervised children should not be allowed in the park.
- There was an issue with fighting in and outside of the park.

5.2 Youth Centre Update- Cynthia Yarran

- Basketball Competition- Hoping to have enough children age between 10yrs to 16yrs old, will be at the town basketball courts. Hoping to have basketball up and running by Term 4.
- Nat and I have applied for a grant for Children's Week of \$1000 for October 2023.
- The Shire has also applied for the Youth Week grant April 2024.
- Boxing Program we have finally sorted Thomas's contract out. Waiting on him to come into sign his contract so that we can start advertising etc
- Have met with new Police in town. PCYC.

5.3 The Groves

- Vehicle access gate for emergencies.
- Fencing will commence either the end of September or beginning of October.
- Concerns about the gate being locked, will always be opened.
- The fencing is in place to protect the flora and fauna -this has been an area of significant concern.
- Prescribed burning.
- The Nyoongar community would prefer the front main entrance next to CBH to be open. But unable to open due to the cost of \$120,000.00+ to construct the required road/rail track crossing structure.
- The Shire is doing the best they can to work together with the Nyoongar community on The Groves.
- A suggestion raised is for the Nyoongar community to seek funding through Ballardong Corp to lobby State Agencies to open the main entrance.

5.4 Signages

- Kangaroo signages in and out of town all ways.
- Park signages, need more signages of park rules i.e. no bikes
- Park signages on main street and McLennan St i.e. children playing safety signs

5.5 Tourism Update

- Tourism working group has been disbanded.
- Two Town Hall Meetings will be held annually to update the community on tourism objectives and outcomes.

5.6 Reconciliation

- The Innovate Reconciliation Action Plan (RAP) has expired.
- The Shire of Quairading RAP 2024-2026 is being drafted and will be presented at the November RAP Meeting for comment.
- Nat & Cynthia Y are working on the draft.
- Once finalised the RAP 2024-2026 will go to the December OCM for Council endorsement.

5.7 Toapin Weir

- Signs have been upgraded.
- Fire pits are done
- Now have running water.
- Charlie Colbung has asked about having a mural on the weir wall.
- Annette Bennell has asked for some trees to be removed on the left sidea.
- Shire installing balustrading hand rail on the rock face for improved safety.

5.8 Housing

- Nat has tried contacting community housing (Homeswest).
- Homeswest to meet with the CEO in October 2023
- The Shire have requested Homeswest attend the November RAP Meeting.

5.9 Sports and Recreation Precinct

- The Shire has submitted their grant application for the DLGSCI CSRFF grant program.
- Stage 1 of the Project includes dual purpose netball/basketball courts, electronic score boards for netball/hockey and football/cricket, fencing, shelter for players and officials.
- The Shire has applied to the CBH Community Grants Program to contribute to this project.
- Looking to have approval for both grant programs by the end of September/early October 2023 on funding approvals.
- Stage 2 of the Sports and Recreation Precinct Project will include a new multi-share pavilion, community function area, bar, gym, multi-use changerooms and accessible ablutions. The Shire will be applying for Commonwealth funding for Stage 2 of the Project.

ITEM 6 COMMUNITY AGENCY UPDATES

6.1 Community Resource Centre – Jill Hayes

- Car Park 'Trash and Treasure' Markets next Saturday, 23rd of September.
- Funding has been secured for Nyoongar Language classes lessons will be available for free as of mid Oct TBC.

- Dr Jack has now started five days a week.
- Has come to attention that the management of the Surgery is lacking Cultural Awareness following the Practice Nurse's resignation.

- The Shire has recommenced a local feral cat's control program. The Shire confirmed you must have firearms license to dispose of feral cats in the 'trap and shoot' program.
