ITEM 6 CHIEF BUSH FIRE CONTROL OFFICER (CBFCO) REPORT

- Fuel loads higher than 2022 and the landscape has dried off very fast.
- Trial of keeping one of the Central BFB trucks at Yoting.
- The Wamenusking truck attended the Corrigin incident several weeks ago.
- Our CBFCO attends DFES meetings so can raise any local brigade issues there on behalf of Quairading.
- Thank you to the Shire for making plant available at incidents.

ITEM 8 COMMUNITY EMERGENCY SERVICES MANAGER (CESM) REPORT

The Fuel cards have arrived for all our Brigades.

- South Carolling- tank location (diagonally OPP). OBRd and Dangin Mears Rd. ES2 fundraising will pay for cost of water and connection.
- Shire plant and staff at incident. (Corrigin fire)
- Water bomber reloading 5/11- Sunday.
- Deployment of resources out of area- process in the CESM or CFC5 are contracted.
- 24- central shed- relocating to Yoting for 23/24 season to trial.

ITEM 9 SHIRE REPORT

The meeting requested an update on training levels throughout the registered volunteers.

Bushfire Safety Awareness training is the minimum course to attend a fire ground.

Firefighting skills will be coming – how to track and enforce the training levels at fire remains an issue - particularly with private and farm response.

Bulk SMS system is working well and now contacts can easily be added.

ITEM 10 OTHER AGENCY REPORTS

Seasonal outlook is that there will be greater chance of higher temperature this summer. DFES is concerned about the impact of heat extrema on vulnerable residence.

A reminder to nominate your grounds controller early.

Public information campaign for consistent messaging - bookmark emergency.wa.gov.au in web browser or on mobile device. Warning levels are Bushfire Advice, Watch & Act and Emergency Warning.

Starlink is a company that provides wireless internet. Devices work like satellite phone. A DFES trial was successful so this will be rolled out to incident response vehicles.

An update provided on state logistic capabilities such as increased number of bulk fuel pods as well as additional tyres and air filters available at incident sites. Also table, chairs, gazebo, hot boxes, eskys ,etc.

Fire mitigation activities around Quairading will focus on Unallocated Crown Land on the north side of town, towards the Waste Site.

The Role of the Fire Weather Monitors is to keep an eye on current weather conditions at the request of the Chief Bush Fire Control Officer, or Deputy in the Chiefs absence in order to decide whether a harvest vehicle movement and hot works ban will be implemented at any given time on a day that is required should the weather conditions warrant it.

ITEM 12 DISCUSSION POINTS

12.1 Pre-Season Synopsis

- High fuel loadings
- Expecting similar weather conditions
- High temps, lower fuel loads, dry already
- Early air support- high response level required.

12.2 Restricted Burning Period/Prohibited Burning Period (RBT/PBT)

No changes to the current Gazetted Restricted and Prohibited Burning Periods for the 2023/24 firebreak notice, all dates are inclusive.

Restricted Burning Period, permits required:

• 16th October 2023 – 31st October 2023

Prohibited Burning Period:

1st November 2023 – 28th February 2024

Restricted Burning Period, permits required:

• 1st March 2024 – 29th March 2024

12.3 Fire Control Officer Training

BFAC wish to hold some FCO training prior to next restricted burning period in February 2024. This training will be a half day refresher covering permits and weather monitoring procedures.

12.4 Letter from Mr B Wilson

A letter was tabled by Mr Ben Wilson regarding use of the North Quairading Fire Truck. He received an initial letter from the Shire and he tabled his response dated 10 February 2023 for the meeting. He is yet to receive a formal reply from the Shire which Ms Natalie Ness said she would follow up and provide a formal reply from the Shire.

ITEM 13 NEXT MEETING DATE

The next Bush Fire Advisory Committee meeting is scheduled to take place on Wednesday 3rd April commencing at 5:00pm in the Council Chambers.
