Question from Cr Trevor Stacey regarding the WhatsApp group and the delay in sending out the messages through the Shire's messaging service, when harvest bans are lifted.

The CESM explains that the occurrence referred to was due to just enough signal to use WhatsApp, but no connection to log into the messaging service at the same time. He had to rely on a Shire employee to send the message out for him, which caused the delay. Going forward, the CESM will ensure that any messages regarding putting in place or lifting Harves or Total Fire Bans will be done through SMS first as the primary source of information, and second through the WhatsApp group.

Pauline Wray (Principal of Quairading District School) -

The school experienced tow lockdowns recently, one was a drill, one wasn't. The incidents proved to be a good opportunity to review and refine processes. The PA might need to be extended to the Cubby in the Pre-primary.

Really strong enrolment numbers, looking positive for next year.

Potential international teacher next year.

Pauline is taking a gap year and will be replaced by Blake O'Halloran.

#### 7.8 Department of Health

Diana Ellison (Quairading Hospital) -

Still regularly dealing with COVID-19. Had a close call recently so everyone coming up to the Hospital is asked to where a mask.

Staffing is a huge problem globally and takes up lots of time to sort.

The hospital was well prepared for the Corrigin Bushfire but received no casualties. Hospital and Parker House considered High Risk in the case of a Bushfire.

Is the Hospital particularly worried about heat related illnesses like Heatstroke? There is a new procedure coming out regarding heat stroke. Main risk is dehydration, but that is a problem all year round.

Cr Jo Haythornthwaite – the chair will encourage all councillors to show interest and take part in committees. In that vein, welcome to Cr Hippisley who is observing today.

The exercise was meant to test how well the committee knew and could implement the LEMA and how effective it was if an incident occurred outside of business hours. It became apparent that vital contact information was incorrect or out of date and that the CESM was the only member of the LEMC who displayed extensive knowledge of overall procedures and regulations.

# Disaster Ready Fund (DRF)

The Australian Government has established the Disaster Rady Fund (DRF) which will provide up to \$200 million per year, over 5 years from 1 July 2023. The DRF will fund projects that build resilience to prepare for or reduce the risk of future natural hazard impacts.

DRF round 2 is expected to open for applications in early 2023. Further information on the timeframes, guidelines and application process will be made available once the Australian Government announces round two.

## **Call for expressions of Interest**

We are inviting expressions of Interest from organisations who have projects that will build resilience in the WA community and prepare for future natural hazard impacts.

Applicants are expected to contribute at least 50 percent of eligible project expenditure. (Although this can be "in kind")

Projects may include infrastructure projects or systemic risk reduction projects.

If you would **like to share in \$200 million of EM grant funding for a project** that will build resilience within your community and please submit your EOI by following the steps below.





- 1. To prepare your EOI, it is recommended that you carefully consider the previous guidelines.
- 2. If you are eligible, fill out the online EOI at this link. <u>https://dfes.smartygrants.com.au/EOI</u>
- 3. To prepare your EOI, it is recommended that you carefully consider the previous guidelines.
- 4. If you are eligible, fill out the online EOI form.

Once the EOI is complete, click on 'Submit' and a copy will be emailed to you along with a reference number. Keep this reference number handy in case you need to contact us with questions about your EOI.

The request for EOIs is an open-ended and ongoing process, with no closing date or deadline.

# However, if you are interested in applying for funding in 2023/24, you should submit your EOI by 15 November 2023.

<u>Further important information:</u> A position has been appointed within the SEMC business Unit in DFES to assist with the development of applications. In particular, to assist develop the problem statement, and provide guidance around quantifying expected outcomes and budget and market viability.

#### Incidents:

It's been a very busy start to the season. In the last month, my 3 shires have had 31 fire incidents, Out of the 31 incidents:

- Quairading's had 11 incidents
- Cunderdin's had 12 incidents
- Tammin's had 8 incidents

I was also request to attend 3 incidents outside of my area (QCT) to assist the region (as per my business plan)

I have also completed 2 weekend shifts in the Regional Operations Centre to support the region.

A few Incidents in Quairading, of note:

- Dry lightning in the Wheatbelt were over 60 incidents were reported for that weather event.
- 3rd Alarm Tree Grass Scrub Fire originating in Bruce Rock and ending up in Quairading with Pantapin going into Emergency Warning.
- 2nd Alarm Tree Grass Scrub Fire in Wamenusking (16ha in Sandalwood Plantation and required water bombers)
- Fire on top of Mt Stirling (Quairading) required water bombers.

In addition to these incidents, the Cunderdin Water bomber Base was stood up 4 times for water bomber reloading.

The Quairading Air base was stood up 2 times.

The Quairading Evacuation Centre was set up for the Corrigin Fire, Thank you for everyone who assisted with this.

A Quairading Fire Whatsapp has been created with over 220 people joining, this has worked well so far.

Appliance position in Yoting is going well. Was quick to get to the fir in Bruce Rock the other day.



# State Wide Evacuation Centre Review – Evacuation Centre Audits

As requested by the SEMC, by the 30<sup>th</sup> of November 2023, all premises that are listed as Evacuation Centres are required to have a completed Evacuation Centre Review, including floorplans, held on file by the Department of Communities. The purpose of the review is to collect the essential data that will determine if a facility is suitable as an evacuation centre for specific risks.

To assist this process, it is requested that the attached form be completed for each centre listed in the LEMA and returned to <u>joanne.spadaccini@communities.wa.gov.au</u> by Monday 13<sup>th</sup> November.

# Emergency Relief and Support – Operations Update

- Review of the State Support Plan The draft State Support Plan Emergency Relief and Support
  has been endorsed by the State Emergency Management Committee (SEMC) Response Policy SubCommittee and will be presented to the SEMC for approval on 4 October 2023. Communities is
  preparing minor consequential changes to the Local Emergency Welfare Plans.
  This has now been approved and endorsed by SEMC on 11<sup>th</sup> October 2023.
- **Capability Audit** Communities procured Nous Group to conduct an audit of Western Australia's emergency relief and support capability. Nous has completed consultation with partner agencies and is finalising the audit report
- **Disaster Victim Identification (DVI)/Mass Fatality** Communities is engaging with WA Police and the State Coroner's Office to strengthen its response to a potential major emergency where mass DVI processes are required.
- **Change Management** On 21 August 2023, Communities commenced a change process to establish a permanent structure to deliver the Emergency Relief and Support (ERS) function under an enhanced service delivery model.
- **Partners Strategy-** To coincide with the change management process, Communities is exploring new ways to engage with partners. From October, Communities will trial a series of monthly workshops, information circulars and desktop exercises with state partners.

## • Kimberley Floods

• Communities continues to provide emergency relief and support services to Fitzroy Valley residents impacted by the Kimberley Floods.

- As of 20 September 2023:
  - 87 people are in Phase 1 Temporary Accommodation across the Fitzroy Valley: including Humanihuts on Country at Bungardi and Tarunda Caravan Park and in the Derby Hostel.
  - From 11 January 2023 until 20 September 23, Communities has responded to a total of 2,090 calls for assistance.
  - 92 Category 3 Assistance applications have been initiated.
- Communities has undertaken planning and preparedness activities in the Kimberley Region ahead of the upcoming wet season. Key activities are integrated into the DFES Wet Season Regional Preparedness Strategy and support the Shire of Derby West Kimberley Resilience and Planning Committee activities.
