4.2 Business Arising

As raised by rap participants/ members and to be considered by the meeting

- To have a Nyoongar representation from the RAP committee, on the Medical Executive Committee, would need to through Council first.
- TOR are out of date, before any recommendations can happen
- Will need to organise a meeting at the CRC for next Wednesday the 19th of June, 1pm. With our 5 RAP Elders. Could open it up to the community if anyone is interested in coming.
- Wendy Hayward from Jeert Mia would like to be apart or the ToR discussion.

ITEM 5 ITEMS FOR DISCUSSION

5.1 Groves

- Original ablution/shower design to be installed by Adam May.
- BBQ and kitchen area not feasible due to length of cabling that will be required to connect power to the site as confirmed by Adam May.
- Jeert Mia CEO investigating funding opportunity with the 2024 Preserve, Promote and Protect our Aboriginal Sites grants.
- Up to \$50,000 available to preserve and protect registered Aboriginal sites.
- The Groves is currently not a registered site with Registrar of Aboriginal Sites within the meaning of Section 5 of the *Aboriginal Heritage Act 1972*.
- Kenneth Kelly, Dept. of Planning, Lands & Heritage has lodged the Reserve for future grant funding.
- Ablution block will maybe start at the next financial year.

- There will be no access road across the railway line.
- Will need to go through Arc Infrastructure, to get railway access due to State Government jurisdiction.
- Maybe have a talk with Matt Wilson, CEO Ballardong Corp, to advocate lobbying the State Government with the access road over the railway line.

5.2 Youth Centre Update- Cynthia Yarran

- Charlie Colbung has completed the Nyoongar Six Seasons Mural on the Inside courtyard wall to add some vibrancy to the Youth Centre in collaboration with our local youth, and school.
- Youth Centre is lacking on numbers on Wednesday afternoon's due to Junior sports trainings.
- Monday's have approximately 3-5 youth attending. A few families that used to live in Quairading and attend the Youth Centre have moved out of town.
- Shire of Quairading NAIDOC Week luncheon will be held on Friday the 12th of July from 11am to 1pm.

5.3 Reconciliation

- Shire of Quairading Innovate Reconciliation Action Plan 2024-2026 (RAP) draft available for edit. Edits were required by Friday, 3 May 2024. No edits received.
- Require a local resident to inform the 'History' section of the RAP (or leave out for this Plan).
- RAP to go to July OCM for Council endorsement.
- Nyoongar History will be taken out of the draft of the RAP 2024-2026 due time constraints for Council endorsements. As no-one has come forward with local history content.
- Draft has been completed and will need feedback from the RAP Elders, RAP Advisory Group and community.
- Reconciliation Advisory Group Meeting- RAP Advisory Group ToR need to be updated.
 Meeting scheduled for the 17^{th of} June at 1pm CRC Meeting Room
- Overall, as a community we will need a budget or back to grand funding to implement the actions outlined in the RAP 2024-2026.

5.4 Sports Precinct

- Sports & Recreation Working Group have met and finalised the Master Plan for the Sports & Recreation Precinct.
- The Master Plan and Concept Design will go to the community for consultation with a 'Have Your Say' page on the Shire website and advertising in the June Banksia Bulletin.
- The 'Have Your Say" link will be published on the SOQ website and distributed via the Shire's social media channels.

5.5 Microgrid Synergy Update

- Would like to have as much feedback as possible on the Paint Quairading REaD (RED) project.
- Will it benefit our community?
- It will help set up for school readiness



PAINT QUAIRADING READ PROPOSAL

RAP Meeting (12/6/24)

Paint the Town REaD: Let's all read, talk, sing and rhyme with children from birth.

Paint the Town REaD (PTTR) is a national, not-for-profit organisation that encourages everyone to read with children regularly from birth so they will be ready to learn at school.

Babies and toddlers who engage in early literacy practices in the home such as reading, talking, singing and rhyming are less likely to show vulnerability on school entry, more likely to achieve well in national literacy and numeracy assessments and more likely to finish school, find employment and lead happy, healthy lives.

PAINT QUAIRADING READ:

In Quairading, we want all our children to have the best opportunity to learn and thrive. The Early Years Network are proposing that we begin a PTTR branch called Paint Quairading REaD.

We work with our early year's services such as the child health nurse, childcare, both playgroups and the school to encourage and promote reading from birth.

We aim to manage community reading boxes, hold events and partner with the Quairading community wherever possible to share the benefits of early literacy.

The Benefits:

Targeting the Early Years (birth to 5 years) is an evidence based critical time in brain development- early intervention is KEY for school readiness.

- School readiness has a ripple effect on the rest of every child's schooling journey (academic/social/attendance etc).
- Evidence of real reduced vulnerability when program is 'fully embedded in community'
- 'No doors' approach- pop up reading sessions in the park/guest readers at local events etc.
- Naturally engaging and fun for all families to participate.
- Endless ideas & possibilities- has the potential to be a long-term project once established in the community.
- Collaboration and community building with the emphasis on the simple message of 'read to your children' getting into every home. All kids in town will be familiar with the egg/mascot and its purpose.

INPUT PLEASE:

- A potential 'egg discovery' event with the aim of every child in Quairading knowing about the egg and what they need to do with it to get the message across.
- Choosing the mascot to be a native animal which is of significance to the Ballardong region.
- Would love to hear additional thoughts/ideas and feedback on the project.
